NOMINATIONS

Written nominations, which comply with the registered rules of the Union, will open 12:00pm (Local Time) on 11 September 2018 must reach the Returning Officer at his/her office or postal address **not later than 12:00pm (Local Time) on 2 October 2018**. If a ballot is required, a candidate may, prior to the printing of the ballot papers, withdraw his/her nomination.

NOMINATION FORMS

Nomination forms are available from the relevant Returning Officer, from the website of the AEC (www.aec.gov.au) or the Union's website. (www.twu.com.au).

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call the relevant Returning Officer to check.

Voting Period

The ballot, if required, will open 12:00 Noon (Local Time) on 12 November 2018 and close at 12:00pm (Local Time) on 30 November 2018.

Scrutineer Appointment

As per the registered rules of the Union, candidates are entitled to appoint a Scrutineer who may be present at all stages of the ballot. The appointment of scrutineers closes at 12:00pm (Local Time) on 30 November 2018. A Scrutineer Appointment form is available from the Returning Officer.

A copy of the AEC's election report can be obtained from the Union or from the Returning Officer after the completion of the election.
