

# SECOND CREDITORS MEETING

## WHAT IS THE SECOND CREDITORS MEETING?

On Tuesday, August 25 the Virgin administrators will release the creditor's report with the Deed of Company Arrangement (DOCA). This will include many of the elements already announced by Bain in the last few weeks. A mass members meeting will be held next week to discuss the details of the proposed DOCA.

## WHAT WILL BE VOTED ON?

Creditors will vote on 4 September. This vote will be on the DOCA sent to creditors on Tuesday. It is important to note that this is NOT a choice between the Bain proposal and liquidation. Liquidation is not an option at this meeting. More information will be provided on this process at the mass meeting next week. If you can't attend the meeting, you'll be able to watch a recording of it later.

## WHAT DO WE DO WITH OUR PROXIES?

The TWU, along with all other members of the Australian Council of Trade Unions (ACTU) have made an application to the court with the support of Virgin Administrators and the management team to make sure all members will be represented at the important upcoming 2nd Creditor's meeting. Making this application means that as union members you will **not** have to nominate a proxy or attend this meeting to be represented.

This means that TWU National Secretary Michael Kaine will automatically vote on behalf of all TWU members. Michael is experienced in these processes and has been working hard throughout the administration of Virgin to secure jobs and conditions for workers.

Of course members who choose to attend the meeting or nominate a proxy will still be able to do so. You have the option to elect out of this and choose your own proxy if you wish. If this is the case you'll need to be registered on the Halo platform.

In the days before the first creditors meeting, the proxy process caused unnecessary confusion and conflict. This is an attempt to stop this happening again in a period that is already uncertain and difficult.
