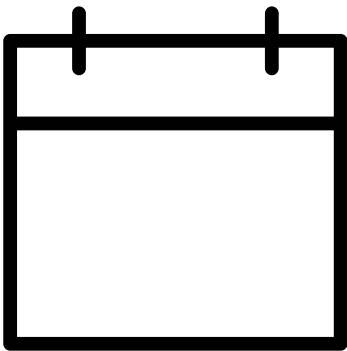


# NATIONAL AGREEMENT VOTING PROCESS
