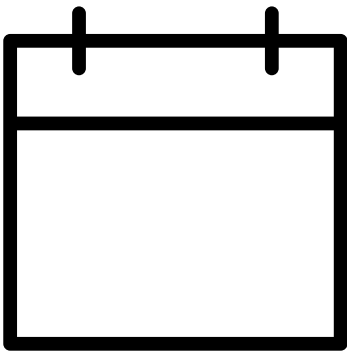


NATIONAL AGREEMENT VOTING PROCESS
