COLES INDUCTIONS HAVE KICKED OFF



Years of campaigning have seen the TWU sign ground-breaking charters with Woolworths (in 2016) and Coles (in 2020).

Coles inductions have kicked off in Toll and Centurion in WA and will be rolled across the rest of the country in 2023.

FUEL TAX CREDITS RESTORED

The TWU, along with ARTIO, the NRFA and NatRoad, collectively wrote to the Federal Government urging it to reinstate the scheme. <u>You can</u> <u>see the letter here.</u>



Transport Minister Catherine King wrote back confirming the credits would be restored when the fuel excise returns in full. **This is a huge win for transport workers.**

EARLY 2023 TIMELINE

Jan & Feb – Pledge cards and commitments to fighting for Legislation

Feb – Claim will be served on 50 largest retail clients and key transport competitors to lift industry standards

March - Claim endorsement for bargains

April – Bargaining will kick off (except for Startrack and FedEx)
