## NEXT STEPS

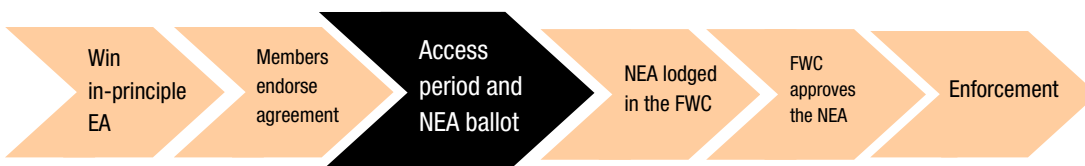
- ▶ **Access Period** from 13-21 Dec
- ▶ **Voting opens from 21 Dec at 6am and closes on 22 Dec at 3pm**
- ▶ The ballot will be conducted site by site using a ballot paper.
- ▶ Within 14 days of announcing a positive YES vote, the \$299 e-voucher will be sent to your payslip email address.
- ▶ The final draft NEA will be lodged at the FWC for approval after the vote result is announced.

## VOTE YES ON AN AGREEMENT THAT DELIVERS:

2023	4.5% (back dated) and \$299 e-voucher	1.5%
1 July 2024	3% (or CPI capped at 4%, whichever is higher) and \$299 e-voucher	1.5%
1 July 2025*	3.5%* (or CPI capped at 4%, whichever is higher)	2%
