The letters explained the reason for the proposed rule changes and attached a document outlining the proposed amendments to the rules (Proposed Amendments) and the SA Branch Proposed Amendment. Copies of the correspondence to the Branch Secretaries (without the attachments) are annexed hereto and marked "B". A single copy of the attachments to the letters to the Branch Secretaries is annexed hereto and marked "C" and "D". The letters fulfilled the requirements of subrule 85(2)(a).
- 6. By letter dated 17 April 2025, the National Secretary provided National Councillors with the Proposed Amendments and the SA Branch Proposed Amendment for their consideration at the 2025 National Council. The letters explained the reason for the proposed rule changes and attached two documents outlining the Proposed Amendments and the SA Branch's Proposed Amendment. 1. AMEND RULE 6 AS FOLLOWS

Delete subrule 6(1) and replace as follows:

6. Admission

(1) A person becomes a member immediately upon making an application in accordance with subrule rule 5(1).

The following consequential amendments are required:

- Delete current subrule 6(2);
- Renumber rule 6(3) and replace with 6(2); and
- Renumber rule 6(4) and replace with 6(3).

2. AMEND RULE 11 AS FOLLOWS

Add a new subrule (7) as follows:

(7) In this rule:

- (a) "in writing" means by letter, email, or signed document in electronic or hardcopy form.
- (b) "delivered to" means delivery via email, post or by hand.

3. AMEND RULE 13 AS FOLLOWS

Add a new subrule (8) as follows:

(8) A Member expelled from the Union under subrule 91(2) has the effect of cancelling Membership of the Union as of the date of the expulsion.

4. AMEND RULE 33A AS FOLLOWS

Amend subrule (5)(a) as follows:

(a) In the event of the death or substantial incapacity of the National Secretary, the National Committee of Management may authorise and empower the National Assistant Secretary to perform the functions of the National Secretary prescribed in rules 68, 71, sub-rules **73(10)** and 75(7), and rule 79 for a period not exceeding 3 months, or until the casual vacancy is filled pursuant to Rule 62.

Amend subrule (5)(e) as follows

(e) Notwithstanding anything else in this rule, in the event that the National Secretary is temporarily absent from the National Office, the National Secretary may authorise, orally or in writing, the National Assistant Secretary to perform the functions of the National Secretary prescribed in rule 33 provided that the National Committee of Management is subsequently notified of all instruments and documents executed under rule 71 by the National Assistant Secretary pursuant to this sub-rule.

5. ADD NEW RULE 94

Add a new rule 94 as follow:

94. Transitional Rule - Branch Assistant Secretary WA

- (1) This rule applies and operates notwithstanding anything else in these Rules.
- (2) If before nominations close for the next quadrennial elections (that is, before noon on the first Tuesday of October 2026), the Western Australian Branch Committee of Management resolve in accordance with Rule 40 to have a position of Branch Assistant Secretary for their Branch, then that position must be filled as follows:
 - (a) The Branch Committee of Management shall, at its first meeting after the meeting at which such a resolution is carried, elect by and from the members thereof a Branch Assistant Secretary by the procedure in (b) (e) below.

- (b) The Branch Returning Officer shall call for nominations at the meeting.
- (c) Any member may nominate any other member for the office provided that the nominee must not already hold the position of Branch President, Vice President or Secretary.
- (d) The nominee shall signify either in writing or verbally willingness to stand for the office. If the Returning Officer finds a nomination to be defective the Returning Officer shall before rejecting it notify the person concerned of the defect and where it is practicable to do so provide the opportunity of the nominee to remedy the defect.
- (e) In the event of an election being necessary the Returning Officer shall conduct such election by secret ballot.
- (3) The person declared elected in accordance with this process takes office immediately and holds office until 10 January 2027, when a person elected to the position under rule 60 shall take office.
- (4) This rule is a transitional rule only and ceases to have effect on and from 10 January 2027.

(a) In the event of the death or substantial incapacity of the National Secretary, the National Committee of Management may authorise and empower the National Assistant Secretary to perform the functions of the National Secretary prescribed in rules 68, 71, sub-rules <u>73(10)</u> and 75(7), and rule 79 for a period not exceeding 3 months, or until the casual vacancy is filled pursuant to Rule 62.

Amend subrule (5)(e) as follows

(e) Notwithstanding anything else in this rule, in the event that the National Secretary is temporarily absent from the National Office, the National Secretary may authorise, orally or in writing, the National Assistant Secretary to perform the functions of the National Secretary prescribed in <u>rule 33</u> provided that the National Committee of Management is subsequently notified of all instruments and documents executed <u>under rule 71</u> by the National Assistant Secretary pursuant to this sub-rule.

5. ADD NEW RULE 94

Add a new rule 94 as follow:

94. Transitional Rule - Branch Assistant Secretary WA

- (1) This rule applies and operates notwithstanding anything else in these Rules.
- (2) If before nominations close for the next quadrennial elections (that is, before noon on the first Tuesday of October 2026), the Western Australian Branch Committee of Management resolve in accordance with Rule 40 to have a position of Branch Assistant Secretary for their Branch, then that position must be filled as follows:
 - (a) The Branch Committee of Management shall, at its first meeting after the meeting at which such a resolution is carried, elect by and from the members thereof a Branch Assistant Secretary by the procedure in (b) (e) below.
 - (b) The Branch Returning Officer shall call for nominations at the meeting.
 - (c) Any member may nominate any other member for the office provided that the nominee must not already hold the position of Branch President, Vice President or Secretary.
 - (d) The nominee shall signify either in writing or verbally willingness to stand for the office. If the Returning Officer finds a nomination to be defective the Returning Officer shall before rejecting it notify the

- person concerned of the defect and where it is practicable to do so provide the opportunity of the nominee to remedy the defect.
- (e) <u>In the event of an election being necessary the Returning Officer shall conduct such election by secret ballot.</u>
- (3) The person declared elected in accordance with this process takes office immediately and holds office until 10 January 2027, when a person elected to the position under rule 60 shall take office.
